

Ordinance Number 99-2

AN ORDINANCE OF THE COUNTY OF ROOSEVELT PROVIDING FOR THE REPEAL OF THE COUNTY'S COLLECTIVE BARGAINING ORDINANCE, ORDINANCE NUMBER 96-1; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEAL OF ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith; AND FIXING AN EFFECTIVE DATE.

Whereas, the County of Roosevelt Board of Commissioners passed Ordinance No. 96-1 in response to the action of the New Mexico Legislature in passing a Public Employees Collective Bargaining Act, and

Whereas, such act shall terminate pursuant to the sunset provision on July 1, 1999, and;


Whereas it is the desire of the County of Roosevelt to repeal its Labor Management Relations Ordinance as soon as practical;

Whereas, after publication of notice by the County Clerk, a public hearing on the above ordinance was held on July 7, 1999.

NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF ROOSEVELT COUNTY, NEW MEXICO, that:

- i. Ordinance Number 96-1 should be and hereby is repealed effective August 7, 1999 at five p.m.
- ii. All ordinances or parts of ordinances specified as deleted in part or in conflict or inconsistent herewith should be repealed to the extent only of such conflict or inconsistency.
- iii. If any chapter, article, division, section, or paragraph of the ordinance for any reason shall be held to be invalid or unenforceable, the invalidity or unenforceability of the such should not affect any other part of County ordinances.


NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF ROOSEVELT COUNTY, NEW MEXICO, that:

A. A public hearing should be held on July 7, 1999 beginning at 3 p.m. at the Roosevelt County Courthouse Commissioner's Room to determine whether or not:


- i. Ordinance Number 96-1 should be repealed effective August 7, 1999 at five p.m.
- ii. All ordinances or parts of ordinances specified as deleted in part or in conflict or inconsistent herewith should be repealed to the extent only of such conflict or inconsistency.
- iii. If any chapter, article, division, section, or paragraph of the ordinance for any reason shall be held to be invalid or unenforceable, the invalidity or unenforceability of the such should not affect any other part of the County code.

B. The Clerk shall cause to publish once in the Portales **News-Tribune** the attached legal notice; and shall make available this proposed ordinance and ordinance number 96-1 available for public review during regular business hours and allow interested individuals to make photocopies upon payment of the required fee.


