- FY23 Financial Audit reflected strong financial stability of the County with no findings, and have received awards from NMOSA and NMC consecutively for FY16 through FY22 Audits
- FY24 Budget- \$18.9M Revenues \$22.7M Expenses
- FY25 Preliminary Budget \$19.2M Revenues \$22.8M Expenses
- Moody's Rating Aa2/Aa3 (high quality/grade, improved from A3 in 2015); the County could see additional improvement in this rating due to eliminating multiple debt services

Operations
