



RESOLUTION NUMBER: 2025-07

Roosevelt County Assessor's Office budget adjustment from the REAPPRAISAL REVENUES 499- into the OVERTIME SALARIES line item 499-5-06-5003.

WHEREAS, the Roosevelt County Board of Commissioners is empowered by statute to adopt rules and regulations, policies and procedures pertaining to the terms and conditions of the employment and compensation of all county employees, whether they be employed by county administration, county departments, or elected officials; and

WHEREAS, the Board of County Commissioners has the authority to oversee the Assessor's Office in the spending of the County Property Valuation Fund. 7-36-16 E

WHEREAS, The County Property Valuation Fund is created from 1% of revenue received, which is the 499- Reappraisal Revenue. 7-38-38.1

WHEREAS, The Assessor's Office staff agrees that individuals must clock out of daily normal hours (after 40 Hours weekly), then clock in under 499- OT hours. Recognizes that OT time cannot be Comped for time off accrual, since that would conflict with the current staff/workload ratio.

WHEREAS, Pay will be time and a half, that includes everything with regular pay, except PERA.

WHEREAS, Daily hours (40 hours clocked) and workload must be maintained. This project starts after the individual clocks 40 hours worked, excluding holiday, time off for vacation, sick leave, etc.

WHEREAS, this perpetual trial project will be checked periodically to see if the goals are being met. It will be discontinued as/if the Assessor/County Manager deems it necessary.

NOW, THEREFORE, BE IT HEREBY RESOLVED, by the Board of Roosevelt County Commissioners on this 18th day of February, 2025, that that a budget adjustment of \$19,000 be made from moving monies from the 499- Reappraisal Revenues to the 499-5-06-5003 OVERTIME SALARIES line item to assist in the Assessor's Office in its Reappraisal Cycle.

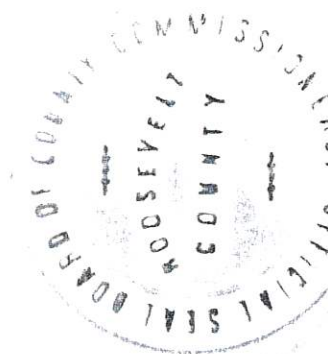
